  performance of the work activities are suitable for their intended purposes, meet
  safety requirements and when peressary, able to be safety operated or used.
- Attend training as required to ensure they have an understanding and ability to

Records of prestart meetings need to be made available to Naylor Love site management on request. Subcontractors who are active on site are expected to be involved by providing representation.
